2018-2021 IAFF Collective Bargaining Agreement

On August 21, 2018, the IAFF and the VOT Management teams tentatively reached agreement on a new three-year contract, and on September 7, 2018, the IAFF members unanimously ratified the agreement. The major highlights are as follows:

1. Article 19 (Pay Plan)

- a. Across the board increase of 1%/2%/2% for fiscal years 2018/19, 2019/20 and 2020/21
- b. Paramedic certification pay increases from 13% to 15% of base pay on 10/1/2018
- c. Topped out employees with satisfactory performance reviews to receive annual, one-time, merit payments of \$1,250
- d. Current EMTs being offered a one-time, incentive payout of 15% of base pay should they attain their Paramedic certification during the life of this 3-year Agreement.

2. Article 26 (Certifications)

a. Village to pay for or reimburse costs associated with certain certifications.

3. Article 34 (Pensions)

- a. Participants will be eligible to enter the DROP within two years of eligibility for normal retirement after attaining 25 years, instead of specifying the 27th year of employment.
- b. For Fire employees hired after October 1, 2010, the Village will match their multiplier to any future police multiplier in respect of their new DB plan approved June 1, 2018.

The estimated cost of the contract for each year is as follows:
