RESOLUTION 59-15, A RESOLUTION OF THE VILLAGE COUNCIL OF THE VILLAGE OF TEQUESTA, FLORIDA, INCREASING THE FISCAL YEAR 2014/2015 GENERAL FUND BUDGET BY \$70,000.00; APPROPRIATING FUND BALANCE AND INCREASING EXPENDITURES IN THAT AMOUNT TO FUND CONSTRUCTION COSTS ASSOCIATED WITH CONNECTING TO THE SANITARY SEWER SYSTEM AVAILABLE AT THE 'TEQUESTA PARK ASSESSMENT AREA'

WHEREAS, the Loxahatchee River District requires that Tequesta Park connect to the available and approved sanitary sewer system by October 1, 2015;

WHEREAS, the Village leases Tequesta Park and is responsible for assessments and improvements under the lease agreement;

WHEREAS, the Village Council approved connecting to the sanitary sewer system available at the 'Tequesta Park Assessment Area',

WHEREAS, an appropriation of Fund Balance is required to fund this project;

WHEREAS, the following budgeted accounts will be increased:

Revenues:

Appropriate Fund Balance, #001-990-399.999 \$70,000.00.00

Expenditures:

Public Works Misc Projects, #001-210-563.600 \$70,000.00.00

NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF THE VILLAGE OF TEQUESTA, PALM BEACH COUNTY, FLORIDA, AS FOLLOWS:

Section 1 The Village Council hereby adopts Resolution 59-15 increasing the fiscal year 2015/2016 General Fund Budget by \$70,000.00, appropriating Fund Balance and increasing expenditures in that amount.
