WHEREAS, the Reverse Osmosis Water Plant #1 degasifier fan and inlet housing filter have become unserviceable and in need of replacement;

WHEREAS, it is the opinion of the Village's engineering firm, Arcadis, that the repair is warranted to stay in compliance with the regulatory agencies and to continue safe plant operations;

WHEREAS, the Water Treatment Plant is requesting to fund this project using Budget Cost Savings funds;

NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF THE VILLAGE OF TEQUESTA, PALM BEACH COUNTY, FLORIDA, AS FOLLOWS:
