ORDINANCE 11-19, FIRST READING, AN ORDINANCE OF THE VILLAGE COUNCIL OF THE VILLAGE OF TEQUESTA, FLORIDA, AMENDING THE VILLAGE CODE OF ORDINANCES AT **CHAPTER 63. ARTICLE II. RIGHT-OF-WAY REGULATIONS, TO RE-NAME THIS ARTICLE AS "PLACEMENT AND MAINTENANCE OF UTILITY AND COMMUNICATION SERVICE** FACILITIES IN VILLAGE RIGHTS-OF-WAY"; TO UPDATE AND ADD CERTAIN DEFINITIONS IN **COMPLIANCE WITH FEDERAL AND FLORIDA LAW; TO RECOGNIZE WIRELESS** COMMUNICATIONS FACILITIES THAT MAY BE PLACED IN RIGHTS OF WAY AND ACKNOWLEDGE THE "ADVANCED WIRELESS INFRASTRUCTURE DEPLOYMENT ACT"; TO PROVIDE NEW AESTHETIC REQUIREMENTS AND PROCEDURAL REQUIREMENTS FOR PLACEMENT OF CERTAIN FACILITIES IN RIGHTS-OF-WAY; TO RECOGNIZE PASS-THROUGH PROVIDERS AS SEPARATE AND DISTINCT ENTITIES, AND TO PROVIDE FOR THE **COLLECTION OF PASS-THROUGH PROVIDER FEES IN ACCORDANCE WITH STATE LAW; PROVIDING THAT EACH AND EVERY OTHER SECTION AND SUBSECTION OF CHAPTER 63.** SHALL REMAIN IN FULL FORCE AND EFFECT AS PREVIOUSLY ADOPTED; PROVIDING A **CONFLICTS CLAUSE, A SEVERABILITY CLAUSE AND AUTHORITY TO CODIFY; PROVIDING** AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.
